



## Visible Emissions Training (aka Opacity or Smoke School) Schedule and Registration Information – October, 2011

**When:** Oct 13 (the field session may continue on Oct 14 for students who do not pass the course on the first day)

**Where:** Prince George, BC – behind the Kin 3 at CN Centre on Ospika Blvd.



### Registration & Fees:

Guidelines established by the BC Ministry of Environment follow the US EPA Method 9 for plume evaluations. Certification is valid for six months and readers must re-certify to continue to perform valid plume evaluations. Initial certification training can be provided to those who are new to visible emission evaluation or those who need a review of fundamentals. Initial training, which will be on the morning of Oct 13, includes a 1/2-day classroom lecture in addition to the field sessions that all evaluators must successfully complete.
